

## Gianni, Origoni, Grippo, Cappelli & Partners wins at the 2019 TopLegal Awards

- **Law Firm of the Year - Current Legal Topic: Privacy:** *"The firm's assistance to Auditel in the complex adaptation of its audience measurement activity to the Gdpr laws caught the attention of the panel. The deal stands out for the size and delicacy of the data processed and required the involvement of the Dpo of all the national TV channels as well as the Italian Data protection Authority."*

The work of all the nominated firms was evaluated by a technical jury - composed of General Counsel and Heads of Corporate and Legal Affairs of leading companies and banks.
